Excerpt from 2014 WLCz summer camp regulations

Responsibilities for keeping the regulations

All participants arriving at the plots belonging to the Woodcraft League are obliged to keep the following rules. Group leaders are obliged to acquaint their members with the rules and regulations. Participants who have invited some guests are responsible for them and their failure at keeping the rules and regulations.

Short time car access

It is allowed to access the camping fields with personal cars between 26 July and 10 August only within times as follows:

- 1) weekend: 25.7.-27.7. until 16:00pm
- a) It is allowed to access the drive connecting the upper and the lower fields only for one hour within the time period as stated above and in the time-table below. The time-table shows time periods for free car access to the spaces in among the tee-pees. There are 5 parking places ready for parking at the lower field. The drivers are asked not to obstruct the asphalt road with any part of their cars.
- b) It's possible to drive onto the upper field and in among the teepees but for the shortest time possible. After that, it is necessary to park the cars at the parking area beyond the Kosovy stream.
- c) There is no car access to any fields on Sunday, 27 July.
- 2) For Friday, 1 August and Sunday, 3 August the regulations stay the same as for the first weekend. Saturday, 2 August is the day of the Annual League Folkmoot and so any car access is prohibited. In case of emergency there is one car available at the parking place at the lower field.
- 3) Parking regulations on Saturday, 9 August and Sunday, 10 August stay the same as for the first and second weekend.(see the time-table below). There is no car access on Friday, 8 August, as the Fare Well Ceremony is taking place in the late afternoon and evening.

Driving into camps during weekdays (except for Fridays) is not allowed. In case of heavy rains please consider any unnecessary driving into the fields to prevent damage to their surfaces.

Parking

It is allowed to park your car for a long period of time only on the other side of the Kosovy stream. You can access the parking place from the main road when you take the turning to the left, about 50 metres before you cross the Kosovy stream(and you get to the bottom of the shallow plain). Continue along the turning as far as a little chaple on the left and turn right there onto a narrow path. The parking places are very near.

Stuff transportation

- a) Two handcarts are available for transportation of the camping stuff from the parking place to the fields.
- b)You can park for a short time at the bar which prevents visitors without permition from driving into the valley of the Kosovy stream(the whole area is a kind of nature protection area). Do not obstruct the road anyhow. You must park your car at the parking place mentioned above when you have finished transportation of your camping stuff into the camp.
- c) You can use a handcart which is available at the parking place. Feel free to ask for help with your stuff!

Tents

Please, look up for the Chieftain and consult a pitch for your tent with him.

Fireplaces

We all have to respect the Forest Act at any time we make fires. It is legal to place your fireplace at the distance of 50 metres from the wood. It is legal to have a fireplace inside a teepee or any other dwelling. Please, consult any fireplace you want to start at the open field with the Chieftain. Always border your fireplace using flat stones. Stones used in previous years are piled at particular places at the edge of both fields. Any fire must not be left unattended! After closing the camp all fireplaces must be removed and the spot restored.

Firewood

It is legal to collect firewood only in the form of kindling or brushwood with the diameter up to 7 cm. Firewood for the campers is delivered before the camping starts and is available at the central storage. Please, keep the place tidy.

Drinking water

Drinking water is available at a pump in the wood beyond the firewood storage. The water is certified as drinking water(the certification renewed before every camping season). Please, do not pollute the place, do not brush your teeth and do not wash yourself there.

Washing

The Kosovy stream flows through a protected area and so it is not allowed to use common washing liquids when washing yourself. Use only biodegradable soap, shampoo and the other liquids of the same character. Always soap or shampoo your hands/body and rinse them with water on the bank of the stream. When cleaning your teeth, spit the spills into the sewage point made for these purposes at several places near the stream.

Garbage and spills

Pour your spills into the sewage points which are made for these purposes at least 10 metres from the stream. Use biodegradable liquids only! Food remains(vegetable and fruit peels) are dumped on the mulch which is placed a few meters from the entrance to the upper field. All garbage is gathered in containers on the drive. Please sort out communal waste from glass, paper and plastics.

Latrines

Always use one of the latrines which are built before every camping season starts. Please, follow the recommendations of the chieftains concerning dumping the other wastes.

Water buildings

Any changes to the waterflow have to be approved. After the camp is over, all catwalks and dams have to be removed.

Pegs

Make sure you have removed all the pegs after packing up your tent. Pegs are a real threat for bare

feet. If you cannot remove it, cut it off or break off the upper part, so that it no longer threatens

anyone.

Bolshevnik

Beware of bolshevnik! Their juices are fototoxic. If they come in contact with skin and sun, there could be some serious skin problems. Yellowish Bolshevniks have been treated with pesticide friendly

to the environment and they destroy the whole plant. Do not destroy yellow Bolshevniks and do not

touch them!

Dogs

Dogs motion in the woods is subjected to the Forest Act. Free motion of the dogs around the camping fields is not restricted. Dogs owners are fully responsible for their dogs and are expected to remove

their dog's droppings. Spoilt dogs should wear muzzles.

Bees

Beware of the bees! They might be aggressive. Keep away from the beehives.

Camp fees

All participants are obliged to pay fees. The money collected is used for fields maintanance,

purchasing the equipment and other purposes. The fees are as follows:

Children under 6 years : free

7-15 year olds: 8 CZK/night

Adult WLC members: 15 CZK/night

Adult non-members: 30 CZK/night
